#### **Other Business**

Before closing the meeting Men's Sheds of WA President, Trevor Taylor briefly informed members of current activities being undertaken by Men's Sheds of WA:

Insurance

Men's Sheds of WA has commissioned Austral Insurance to review current insurance policies available to Men's Sheds. Sheds will be asked to complete a survey regarding their insurance requirements. All Sheds are asked to participate.

Website – find a shed

The Men's Sheds of WA website has a new Find a Shed feature. All Sheds are asked to check the information listed against their Shed and to provide personalised descriptions as well as photos that represent their Shed.

Partnerships

Men's Sheds of WA has sourced discounts for Men's Sheds with *Midalia Steel* and *Carbatec* to offer Sheds a discount.

ShedQ

As advised at the zone meetings we are seeking a office for the Men's Sheds of WA team 'ShedQ' - we are currently determining our requirements.

#### 9. Questions to the Board

- Q. Vincent Men's Shed queried if the Insurance Broker was local and if he was undertaking this review on behalf of WA Sheds only.
- A. Yes. The insurance broker 'Austral Insurance' is local and is only looking for information to support the Men's Sheds throughout WA.
- Q. Melville Community Men's Shed asked about the status of the relationship between Men's Sheds of WA and the Australian Men's Shed Association.
- A. Trevor Taylor read out the response Men's Sheds of WA received from a representative of the Federal Minister of Health, the Hon Greg Hunt MP following a query on the expected publication date of the Commonwealth Dept of Health review on the governance and operations of AMSA and the National Shed Development Program.

Trevor also thanked AMSA for their sponsorship of the Men's Sheds of WA State Conference 2021 and noted the collaborated effort between Men's Sheds of WA and AMSA in hosting the Men's Shed Week 2021 long lunch.

- Q. Manji Men's Shed asked if Men's Sheds of WA had advice for Sheds on obtaining DGR Status.
- A. Men's Sheds of WA and Shed members who have been through the process advised on the requirements on being successful in a DGR application including:
  - Changing your Sheds constitution on types of membership and how members are approved
  - Ensuring there is a revocation clause in your constitution
  - Registering yourself as a Health Promotion Agency (which you are)
  - Men's Sheds of WA has information on its website to support Sheds through the process and Sheds can reach out to the team if they need assistance.

Trevor Taylor thanked everyone for their attendance and participation and closed the meeting at 5.24 pm.
